

## **Application for pupil premium funding**

We are asking parents and guardians whose children go to a school in Southwark and have a statutory entitlement to Free School Meals to complete this form. We will then be able to confirm whether the school is entitled to claim the Pupil Premium for your child.

Any qualifying family that registers their eligibility by simply completing this form will help raise Pupil Premium money for the school following a government commitment to pay schools currently £1,900 per year for each child registered. This is money the school can benefit from and use to fund new equipment or maybe more teaching staff.

Please complete all sections of this form using black ink and BLOCK CAPITALS if your joint family income is less than £16,190 or you are in receipt of any of the benefits detailed in section 3 below. Please return your application directly to your child's school which will then be processed in confidence by the local authority.
